Events and Actions of our JPIC committee:

Faith and Housing Workshop

Angela, Clo, Emma and Sharon attended a session on November 20 where people of different faith expressions looked at possible approaches to low-income housing. St. John's ranks very high in Canada with its lack of affordable housing and as the economy improves and rents go higher, the situation worsens for those kept poor. Cochrane Street United Church has a collaborative plan to get funding to use a large portion of that complex for ten units of supportive living.

CRC Atlantic JPIC

Flights were cancelled and Emma and Clo missed this meeting in October. The report from the group called upon Canadian Bishops to become more vocal in calling Canada's attention to the problem of *Human Trafficking*.

Sustainable Development Goals Post 2015

The United Nations Synthesis Report authored by the Secretary-General, Ban Ki-moon, spells out the necessary components for a realistic outcome on Sustainable Development: inspirational vision, a practical plan, adequate means, and a framework to monitor implementation. The six essential elements to frame and reinforce these goals are: dignity - end of poverty; people - ensure healthy lives; prosperity - strong inclusive economy; planet - protection of our ecosystems; justice - promote safe societies; and partnership - global solidarity.

IPA Survey: Our JPIC committee was asked to discuss and reply to an IPA Networker Survey sent to us by Sr. Elena Hoye. The survey asked questions around the specific interventions (ministries) PBVM 's are undertaking regarding issues like Human Rights, Education, Women, Children, Indigenous Peoples, Trafficking, and Sustainable Development. Lois agreed to respond to the survey after receiving permission to use their names from Sisters who may currently be involved in related ministries.

Read Helen Martinez Journal of her experience at the UN. This is circulated among the Conference of Presentation Sisters on the E-news and in our Communications to Sisters.

The "People of the World" November statement on the typhoon calamities in the Philippines calls on governments and leaders to come up with a new framework and ambitious goals to stop the climate crisis, protect the poor and vulnerable, make the polluters pay, and bring reparation to all victims of the climate crisis. Not-So-Good News

The UN General Assembly's vote on the modalities for the implementation of the UN's debt restructuring resolution was passed by an overwhelming majority. The vote count taken on December 5th was: 128-yes; 16-no; 34-abstain. Canada was one of the 16 "No" votes. Negotiations on the debt restructuring resolution are to kick off in January 2015. Many European countries abstained from vote, similar to the 9 September vote on the actual resolution.

Good News

On 4 December, UN Secretary-General Ban Ki-moon informally presented an advance, unedited version of his synthesis report on the post-2015 development agenda to UN Member States. "The Road to Dignity by 2030: Ending Poverty, Transforming All Lives and Protecting the Planet" outlines a vision for Member States to consider carrying forward in negotiations leading up to the UN Special Summit on Sustainable Development in September 2015 that will adopt the post-2015 development agenda.
